# A By-Law to Provide for the Annual Remuneration to Members of Council for the Corporation of the City of Kingston

(Short Title "Council Remuneration By-Law")

Passed: March 22, 2022

By-Law Number 2022-48

A By-Law to Provide for the Annual Remuneration to Members of Council for the Corporation of the City of Kingston, and to Repeal By-Law Number 99-169, A By-Law to Provide for the Annual Paying of an Annual Allowance to the Members of Council for the Corporation of the City of Kingston, as Amended, in its Entirety ("Council Remuneration By-Law")

#### Passed: March 22, 2022

**Whereas** the Council of the Corporation of the City of Kingston deems it expedient to repeal and replace By-Law Number 99-169, A By-Law to Provide for the Annual Paying of an Annual Allowance to the Members of Council for the Corporation of the City of Kingston, as amended, which was passed on May 19, 1999;

**Therefore be it resolved that** the Council of The Corporation of the City of Kingston hereby enacts as follows:

- 1. An annual remuneration shall be paid to each member of Council of the Corporation of the City of Kingston, as set out in Schedule A attached hereto.
- 2. The annual remuneration paid to members of Council does not include their remuneration as a member of the Kingston Police Services Board or any agency, board, commission, corporation, society or other similar organization to which the member is appointed by Council. This remuneration shall be separate and above the annual remuneration paid to members of Council.
- 3. Such remuneration shall be paid bi-weekly, and in the event of the death of a member of Council or upon their ceasing to be a member for any reason before the expiration of their term of office, the amount payable to them or their personal representative shall be in proportion to the period of their service during such term.
- 4. Effective January 1, 2023 the annual salary and car allowance for the Mayor, Deputy Mayor and members of Council shall be adjusted annually to the cost of living, as established by the Consumer Price Index on the previous October 1st.

- 5. Remuneration for a member of Council attending an out-of-town conference will be provided as set out in Schedule A of this by-law.
- 6. The current benefit package for members of Council of the Corporation of the City of Kingston shall be maintained, and any benefits shall be paid separate and above the annual remuneration paid to members of Council.
- 7. This By-Law shall come into force and take effect on the date of its passing.

This By-Law was given three readings and passed on March 22, 2022

### Schedule A – Remuneration and Out-of-Town Conference Expenses

#### Remuneration

Mayor Annual Remuneration: \$129,000.00 District Councillor Annual Remuneration: \$45,000.00 Additional monthly compensation for Deputy Mayor: \$250.00

#### **Travel Allowance**

Travel by car shall be reimbursed at the rate of \$0.58 per kilometre per return trip measured from Kingston City Hall to the destination. The cost of an economy class train or plane fare shall be reimbursed. Upgrading to a higher level will be permitted where circumstances warrant, including time of day and distance being traveled
