Subject: Parking By-law – Minor Amendments

### **Executive Summary:**

This report requests approval of minor amendments to By-law Number 2010-128, "A By-law to Regulate Parking" to add parking regulations to address traffic flow and safety issues on a section of both Queen Mary Road and John Street.

It is recommended that the amending by-laws be presented for all three readings such that the signage can be installed prior to the start of the winter season.

#### Recommendation:

**That** a by-law be presented to amend City By-law Number 2010-128 "A By-law to Regulate Parking", as amended, as per Exhibit A in Council Report 17-299; and

**That** the amending by-law be presented for all three readings to allow the correct signage to be installed prior to the winter season.

## **Options/Discussion:**

The purpose of this report is to recommend minor amendments to By-law 2010-128, "A By-law to Regulate Parking". The proposed changes are formally reflected in the attached Exhibit A.

## **Queen Mary Road**

A no parking area will be added on the west side of Queen Mary Road from Bath Road northerly to the end of Queen Mary Road. This no parking area will address on-street parking congestion that has been observed from the adjacent nursing home facility and apartment buildings that has impacted traffic flow.

#### John Street

A limited-term parking zone will be added on the south side of John Street adjacent to the Mulberry-Waldorf School. This 3-hour parking zone will provide for a student pick-up/drop-off area for the school and create a short-term parking option for visitors to the site and surrounding area.

This option has been developed in consultation with the administration and clients of the Mulberry-Waldorf site as a means to address increased parking utilization in the area that has impacted the school, which has no on-site parking options.

# A By-Law to Amend By-Law Number 2010-128 "A By-Law to Regulate Parking".

The Council of The Corporation of the City of Kingston enacts as follows:

- 1. By-law No. 2010-128 of the Corporation of the City of Kingston entitled "A by-law to regulate parking", as amended, is hereby further amended as follows:
- 1.1 Schedule F-1, No Parking At Any Time, is hereby amended by adding the following hereto:

# Schedule F-1 No Parking At Any Time

Street	Side	From
Queen Mary Road	West	Bath Road northerly to the north end of Queen Mary Road

1.2 Schedule G-1, Limited Term Parking Zones, is hereby amended by adding the following hereto:

# Schedule G-1 Limited-Term Parking Zones

Street	Side	From	Times	Limit
John Street	South	60 metres west of Montreal Street 50 metres westerly	Mon to Sun	3 hours

2. This By-Law shall come into force and take effect when required signage and equipment has been installed.
