Whereas some ceremonies in Kingston intentionally release latex or Mylar/foil balloons outside into the sky as a symbolic action; and

Whereas when a balloon reaches a certain level of height and pressure, the balloon will burst into small little fragments and fall from the sky; and

Whereas balloon fragments can be spotted on the shoreline in the Kingston area; and

Whereas there is scientific proof that marine life assumes these balloons are a source of food and fragments of balloons have been found in the stomachs of marine life and balloon fragments and string has been found wrapped around marine life; and

Therefore Be It Resolved That staff prepare a report by the end of Q1 2018 to recommend to the Administrative Policies Committee how the city bylaw(s) and corresponding policies, if applicable, can be amended to ban the intentional or ceremonial release of latex and Mylar/foil balloons in the outdoors in the municipality of Kingston.
