Report Number 69

To the Mayor and Members of Council:

Heritage Kingston reports and recommends as follows:

### 1. Applications Recommended for Approval (Statutory Consultation with Heritage Kingston)

#### i. Approval of an Application for Heritage Permit – 103 Stuart Street

**That** alterations to the property at 103 Stuart Street, be approved in accordance with details described in the application (File Number P18-069-2018), with said alterations to include:

- 1. Relocating an existing door on the east wall to an existing window opening, and replacing the door with a window;
- 2. Installing two new compressor units at the southeast corner of the building;
- 3. Installing two mechanical louvers into existing windows on the north side of the building; and

**That** the approval of the alterations be subject to the following conditions:

- 1. A Building Permit shall be obtained;
- 2. All masonry works shall be completed in accordance with the City's Policy on Masonry Restoration on Heritage Buildings;

That city staff measure the current noise (db) levels and following the installation of two new compressor units, measure the subsequent noise (db) levels to determine if an increase in noise levels has occurred. In the event that an increase in noise is significant, City staff shall work with Queen's University to determine if mitigative controls are required. Where mitigation requires alteration to the property, subsequent heritage approvals shall be obtained.

    - "a) the management or use of resources; b) resource-based recreational uses (including recreational dwellings); c) limited residential development; d) home occupations and home industries; e) cemeteries; and f) other rural land uses."
    - These activities of the applicant's business are not permitted under PPS 1.1.5.2. Furthermore, the Applicant's business is neither a home occupation or a home industry as the business owner does not reside on the property and never has.
  - b. **PPS 1.1.5.7** "Opportunities to support a diversified rural economy should be promoted by protecting agricultural and other resource-related uses and directing non-related development to areas where it will minimize constraints on these uses."
    - The application results in the conversion of farmland to create a very large outside industrial compound. The proposed land uses are not related to agricultural, and should be directed to another area to minimize constraints on agricultural uses.
  - c. **PPS 1.1.1.d** "Healthy, liveable and safe communities are sustained by: avoiding development and land use patterns that would prevent the efficient expansion of settlement areas in those areas which are adjacent or close to settlement areas."
    - This application would allow an industrial contracting operation to be established in the middle of what is predominantly a residential area. This application will prevent the efficient expansion of the settlement area because the proposed industrial use is not compatible with residential development.
- 2. It fails to conform with or is in conflict with an applicable Official Plan policy, specifically,
  - a. 3.13.19 "Small-Scale Industrial and Commercial Uses"
    - "Small-scale industrial and commercial uses in the Rural designation can provide a modest means of starting a business. The businesses that grow are expected to move to more urban settings. Other businesses may

employ local craftsman or artisans and remain small. Such businesses may be permitted in the Rural designation provided the uses are limited in size and do not have adverse effects on adjacent land uses through noise, vibration, reduction of privacy, traffic or other impact or hazard. New small-scale industrial and commercial uses are allowed by an amendment to the zoning by-law. Such amendments must set out specific limits on use, size, location and number of employees. All new small-scale industrial and commercial uses in the Rural designation are subject to the Site Plan Control By-law in accordance with the Planning Act."

The application does not conform to 3.13.19 as the applicant's business has become well established over the last 20 years, has a workforce of up to 12, and has been awarded significant Federal government fencing contracts. The business is not a startup nor is it small scale. Furthermore, the applicant proposes to relocate their entire business to the subject site, from their administrative offices to heavy equipment, inventory and parking for up to 12 employees. The use of the subject property will neither be small nor limited.

#### b. **4.6.32** – "Truck Traffic"

"The City will minimize the adverse effects of truck traffic on the functioning of roadways and on the amenity of residential areas by:

- a) defining truck routes in the City and prohibiting truck movements on streets in residential areas, wherever warranted;
- d) situating land uses that are likely to generate high levels of truck traffic to locations with suitable road and access conditions, having regard to compatibility with permitted uses;
- e) encouraging trucks that provide service to industrial areas to travel within such areas and not through residential or commercial areas;
- f) restricting home occupations that would generate truck activity;"

The proposed application is in conflict with 4.6.32 as it encourages and allows commercial traffic in and through a predominantly residential area.

#### c. **3.6.B** "General Industrial designation"

"The General Industrial designation is an area of employment intended to provide convenient locations for manufacturing, wholesale trade, construction, transportation, storage, communications, utilities, and similar uses. These uses will be grouped into distinct employment areas to foster economic synergy and avoid or mitigate adverse effects on residential uses or other sensitive uses."

This application is in conflict with the intent of 3.6.B as it proposes to establish an industrial contracting business in the middle of what is predominantly a residential area instead of directing it to a distinct employment area with similar and compatible uses. Furthermore, the

proposed application would result in commercial activities that would have adverse effects on the existing residential uses.

The ceremony will be held at Queen's University around 1 pm to mark this anniversary and the continuing friendship between Canada and the US and all Councillors are encouraged to attend.

As Roosevelt said in Kingston that day: "We as good neighbours are true friends."
