# **Executive Summary:**

In accordance with the provisions of the Police Services Act, R.S.O. 1990, c.P.15, the City may appoint one or more municipal law enforcement officers to act as peace officers for the purpose of enforcing the by-laws of the municipality.

The purpose of this report is to amend By-Law Number 98-9 "A By-Law to Appoint Municipal Law Enforcement Officers of The Corporation of the 'New' City of Kingston" to reflect changes in the status of employees with Kingston, Frontenac and Lennox & Addington Public Health (KFL&A Public Health) who enforce the City's By-Law Number 2002-231, "A By-Law to Regulate Smoking in Public Places and Workplaces in the City of Kingston" and By-Law Number 2008-95, "A By-Law of The Corporation of the City of Kingston to Control the Idling of Vehicles & Boats" as well as to appoint those employees of Utilities Kingston to enforce By-Law 2006-122 entitled "A By-Law to Provide for the Regulation of Water Supply for the City of Kingston" and By-Law 2008-192 entitled "A By-Law to Provide for the Regulation of Waste Water Services and Discharges to Municipal Sewers for the City of Kingston".

### Recommendation:

**That** a by-law be presented to amend City of Kingston By-Law Number 98-9, "A By-Law to Appoint Municipal Law Enforcement Officers of The Corporation of the 'New' City of Kingston", as amended, as per Exhibit 'A' in Council Report Number 18-375; and

**That** the by-law attached as Exhibit A to Report Number 18-375 be presented to Council for all three readings.

## **Options/Discussion:**

Under the Police Services Act, R.S.O. 1990, c.P.15, the City may appoint one or more municipal law enforcement officers who shall be peace officers for the purpose of enforcing the by-laws of the municipality.

By-Law Number 98-9 "A By-Law to Appoint Municipal Law Enforcement Officers of The Corporation of the 'New' City of Kingston", appointed employees of Kingston, Frontenac and Lennox & Addington Public Health (KFL&A Public Health) for the enforcement of By-Law Number 2002-231 entitled "A By-Law to Regulate Smoking in Public Places and Workplaces in the City of Kingston" as well as the City's By-Law Number 2008-95 entitled "A By-Law of The Corporation of the City of Kingston to Control the Idling of Vehicles & Boats". With recent employee changes, KFL&A Public Health requires an amendment to By-Law Number 98-9 to update the list of employees responsible for the enforcement of the City's By-Law Number 2002-231 and By-Law Number 2008-95.

Utilities Kingston has requested that three of its employees be appointed as municipal law enforcement officers of the Corporation of the City of Kingston for the purpose of enforcing the provisions of By-Law 2006-122 entitled "A By-Law to Provide for the Regulation of Water Supply for the City of Kingston" and By-Law 2008-192 entitled "A By-Law to Provide for the Regulation of Waste Water Services and Discharges to Municipal Sewers for the City of Kingston.

Specifically, Utilities Kingston's Cross Connection Control Coordinator is responsible for enforcing regulations in By-Law 2006-122 pertaining to cross connections and backflow prevention. Under By-Law 2008-192 Utilities Kingston's Quality Assurance Operator is responsible for compliance matters relating to sewer use and wastewater treatment matters, and the Utilities Kingston employee responsible for conducting enforcement related to illegal connections and sources of extraneous flows entering the municipal sewer system. Both these individuals require the authority to enforce By-Law 2008-192.

By-Law Number 98-9 is to be amended as per the draft by-law attached as Exhibit 'A'.

# A By-law To Amend By-Law Number 98-9 "A By-Law To Appoint Municipal Law Enforcement Officers Of The Corporation Of The 'New' City of Kingston"

**Whereas** pursuant to the Section 15 of the Police Services Act, R.S.O. 1990, c.P.15, the Council of The Corporation of the City of Kingston may appoint one or more municipal law enforcement officers who shall be peace officers for the purpose of enforcing the By-Laws of the municipality;

**Therefore be it resolved that** the Council of the Corporation of the City of Kingston hereby enacts as follows:
