# **Executive Summary:**

In accordance with the Service Level Agreement entered into between the City of Kingston and Kingston Economic Development Corporation (see Report to Council 16-325), the attached report (Exhibit A) provides detailed reporting on Q3 2018 for the economic development organization. #### **Investment Attraction & Aftercare**

- Kingston EcDev joined the Ontario East Economic Development Commission and the Ontario Investment Office at the Ontario Food Cluster tradeshow in Chicago from July 15-18. Ten Economic Development Offices from across Ontario participated to promote their regions for agribusiness investment.
- Construction on the Feihe Canada Royal Milk facility is proceeding well and reported on schedule. Commissioning is scheduled to begin in June 2019. Recruitment for Canada Royal Milk staff will follow the equipment installation and commissioning schedules closely.

## **Business Retention and Expansion (BR&E)**

- ➤ Kingston EcDev and the Greater Kingston Chamber Hall of Commerce hosted the annual Business Hall of Fame event in June to recognize the contributions of outstanding business leaders in the Kingston community.
- ➤ Correctional Services of Canada announced that Kingston has been selected as the site for its new, state of the art National Training Academy. Formerly housed in Edmonton, an interim training site has been set up in Kingston. The new facility will be developed over the next five years. The interim site will see approximately 125 recruits per session undergoing basic and advanced training across the country.
- Representatives from the provincial Ministry of International Trade division (part of the new Ministry of Economic Development, Job Creation and Trade) visited Kingston in August to meet with the Economic Development Office and tour local companies. Work is underway to organize a monthly Kingston "office-day" for Ministry representatives to meet with local companies interested in exporting.

#### **Start-ups and Entrepreneurs**

- ➤ The provincially funded Summer Company program had another successful year. Fifteen student entrepreneurs completed the program which provides business start-up funding and business coaching/mentoring support.
- Kingston EcDev partnered with Queen's Office of Partnerships & Innovation on an ecomapping project. The objective of the research is to have a clearer picture of what's happening in Kingston and area for entrepreneurs and innovators and to create tools to help individuals and small businesses at all stages to better navigate and access resources.
- ➤ Kingston EcDev has implemented a weekly open houses called "Open for Business" which provides individuals and small businesses with an overview of services available through the Economic Development Office, funding programs available and community resources. Open for Business takes place every Thursday from noon 1pm at Innovation Park, 945 Princess Street.

#### **Workforce Development**

- ➤ Kingston EcDev engaged actively with both Queen's University and St. Lawrence College students attending the Graduate Resource Fair, Queen's University Career Fair, Queen's Sidewalk Sale as well as SLC Connect. Staff were on site to showcase Kingston employers currently hiring and share information on living and working in Kingston.
- ➤ Kingston EcDev participated in a virtual career fair organized by In-TAC, an Ottawa based agency that works with skilled job seekers across Canada and over 130 countries around the world. Through this event, Kingston EcDev received access to a resume database which was shared with local employers.
- ➤ In partnership with the 1000 Islands Workforce Development Board, Kingston EcDev is administering the annual EmployerOne survey to local businesses. The report, to be released early in the new year allows businesses to share important information about hiring challenges and specific workforce needs. This valuable information is shared with organizations including Job Developers, Educators, Economic Developers, Industry



Associations and Business Support Agencies to help shape programming related to local workforce development.

### **Emerging Sectors – knowledge Industries, tech transfer, innovation enablement**

- Kingston EcDev signed a Memorandum of Understanding in July with FUSE, a Kingston based not for profit created with GreenCentre Canada, Kingston Process Metallurgy and DuPont in 2017 to attract and support start-up companies that are developing new chemical processes.
- Kingston EcDev signed a Memorandum of Understanding with NRI India Start-up, an organization supporting Indian technology start-up ideas across the world to develop global companies. NRI India Start-up is working with the Economic Development Office to support the attraction and relocation of Indian companies interested in establishing a presence in Canada.
- Kingston EcDev collaborated with the Conference Board of Canada to develop a benchmark report card for Kingston. This report presents an in-depth study of Kingston's attractiveness to skilled workers and businesses in relation to 11 other Canadian cities. The Conference Board benchmarked 22 indicators that are critical to a city's competitiveness. These indicators are grouped into three categories: economy, innovation, and society. Kingston places in the top half of the rankings in all three categories, boding well for its outlook.
- During the summer, Kingston EcDev hosted Ontario Ministry of Economic Development, Job Creation and Trade representatives as well as the Ontario Investment Office to visit Kingston and be introduced to academic partners and local businesses.

## **CORPORATE UPDATES**

- ✓ The Finance Committee last met on June 28 to review Financial Reports to the end of May, 2018. Financial reports for the months of July & August were circulated via email. Regular meetings will resume on September 27, 2018.
- ✓ The HR & Nominations Committee met on July 5 to discuss succession planning, CEO performance evaluation, policy manual updates and board 2019 recruitment.
- ✓ The Strategic Planning Committee convened on July 24 to determine the Committee deliverables as well as review and discuss the strategy development process. A second meeting was held on September 6 to discuss vision and mission.
- ✓ Kingston EcDev hosted Watertown, NY representatives in Kingston on August 18 as part of Canada-US Friendship Day celebrating the 80<sup>th</sup> anniversary of President Roosevelt's historic address at Queen's University.

- ✓ Kingston EcDev is pleased to be participating in the KEYS Professional Internship for Newcomers Program. Welcome to Sulaiman Qureshi who has joined the team as Reception/Administrative Assistant.
- ✓ Kingston EcDev attended the United Way KFL&A Kick-off Breakfast on September 7 to hear this year's region-wide fundraising goal of \$3,456,000. The goal of Kingston EcDev's campaign is \$2,500.
- ✓ Business Development Officer Carey Bidtnes has accepted an offer as Human Resources Manager for Feihe Canada Royal Milk. Her last day with the Corporation will be September 21. We congratulate Carey and wish her all the success.

#### **ATTRACTION & AFTERCARE**

- ✓ Kingston EcDev participated with Ontario East Economic Development Commission and the Ontario Investment Office in the Ontario Food Cluster tradeshow in Chicago from July 15-18. Ten Economic Development Offices from Ontario participated in the tradeshow.
- ✓ Kingston EcDev and Tourism Kingston hosted a delegation of 18 people from Chung Cheong Buk Province, South Korea at the Tett Centre for Creativity and Learning on September 5. The group of professionals working in government departments as well as universities were visiting cities across North America to learn about best practices



- across a number of topic areas. Chung Cheong Buk selected Kingston to learn about our attraction and aftercare strategies and workforce development and in-migration.
- ✓ Feihe Canada Royal Milk has recently announced the recruitment of Mr. Zhiwen Yang as the plant's General Manager. Mr. Yang has more than thirty years of experience in dairy processing and manufacturing, and he joins the Feihe Canada Royal Milk Team from Nestle's operations in Tianjin City, China. Mr. Yang had indicated he will begin building the senior management team quickly with recruitment for senior management roles in quality assurance, packaging and production beginning in early October. The recruitment, hiring and onboarding of new employees will be carried out in phases between November of this year and January 2019.

#### **BUSINESS GROWTH & RETENTION**

- ✓ Kingston EcDev hosted an one-day workshop, Developing a Hazard Analysis and Critical Control Points (HACCP) Plan on September 11. The workshop, delivered by Shannon Nguyen, Food Safety Advisor with the Ontario Ministry of Agriculture, Food and Rural Affairs, provided the participants with accredited training for those that wish to become HACCP certified. Fifteen individuals representing nine businesses participated.
- ✓ Representatives from the provincial Ministry of International Trade division (part of the new Ministry of Economic Development, Job Creation and Trade) were in Kingston on August 21. With recent provincial government changes, program activity and services are currently on hold while a review is undertaken. Work is underway to organize a monthly Kingston "office-hour" day for Ministry representatives to meet with Kingston companies interested in exporting.
- Chair Judith Pineault and Donna Gillespie attended the Economic Developer's Association of Canada's seminar on Investment and Trade Uncertainty – Economic Development in the age of NAFTA, CETA and CPTPP. The session held in Fredericton, NB brought together economic developers from across the country to discuss challenges and opportunities with different trade agreements and look at ways to maximize crossborder and global alliances.

#### **START-UPS & ENTREPRENEURS**

- ✓ Summer Company concluded at the end of August for the 15 participating student entrepreneurs. Feedback from students has been positive on the program which included funding and mentoring support throughout the summer months.
- ✓ Kingston EcDev is "Open for Business". Starting Thursday, September 27 at noon, information sessions will be offered to help the community learn about the programs and services offered at Kingston EcDev to start and grow a business. Topics include government programs, financing and grants, events and workshops.
- ✓ October is Small Business Month planning is underway for events to celebrate Kingston's small business sector.

- ✓ Kingston EcDev, Kingston Accommodation Partners and Tourism Kingston Board members met on August 22 to learn about City Nation Place America conference held in June. The conference focussed on how economic development organizations and tourism marketing organizations can work together for people and investment attraction. A copy of the presentation can be made available upon request.
- ✓ Kingston EcDev participated in the Queen's School of Graduate Studies Welcome and Resource Fair on September 4 to connect with new and returning graduate students and encourage them to think of Kingston as a place to live once they have completed their studies. In collaboration with Tourism Kingston, Kingston EcDev attended the Queen's Sidewalk Sale on September 5 to encourage students to explore life outside of Queen's University campus and the Kingston Multicultural Arts Festival on September 9 to promote Kingston careers and lifestyle opportunities.
- ✓ Kingston EcDev is working with In-Tac, a newcomer pre-landing service company based in Ottawa. In-Tac offers programs, training and services that introduce internationally educated professionals to Canadian workplaces.
- ✓ Working with sector leaders in the call centre industry, Kingston EcDev will be attending the Canada Newcomers Job Fair in Montreal in October to promote Kingston career opportunities and attract bilingual job seekers to the community.
- ✓ Kingston EcDev is working with Queen's university on the 2019 Career Apprenticeship Program. Funder Alan Rottenburg has committed to investing in 35 apprenticeship opportunities for graduating Arts and Science students with local businesses in 2019.
