Executive Summary:

Staff issued a Request for Proposals (RFP) for the purchase of one 2019 model year, three-quarter-ton, high roof cargo van. This unit is an addition to the Solid Waste Services fleet. Council approval is required because only two proposals were received and staff is not recommending the lowest price submission.

Recommendation:

That the Director of Transit & Fleet Services be authorized to enter into a contract, in a form satisfactory to the Director of Legal Services, with Petrie Ford for the purchase of one 2019 model year, three-quarter-ton, high roof cargo van (F31-TIS-TS-FL-2019-11) for the total purchase price of \$37,041 plus applicable taxes.

Options/Discussion:

Staff issued a Request for Proposals (RFP) on behalf of the Solid Waste Services for the purchase of one 2019 model year, three-quarter-ton, high roof cargo van. This cargo van will be equipped with shelving, drawers, a roll-up awning on the curb side and a tow package capable of hauling OSKAR (Off Site Kingston Area Recycler), the City's mobile waste diversion trailer, to public education and training events.

This unit is an addition to the Solid Waste Services fleet. The submissions were evaluated using the following criteria:

- Pricing and Related Costs 35%
- Specification Compliant 30%
- Fuel economy and GHG -22%
- Warranty 10%
- Accessibility Standards for Customer Service, Ontario Regulation 429/7 3%

Two proposals were received in response to the RFP. The proposal submitted by Blue Mountain Chrysler Ltd. in the amount of \$34,651 plus applicable taxes did not meet the required specifications because it did not include all weather certified tires and was unable to provide enough towing capacity to accommodate OSKAR.

The proposal submitted by Petrie Ford Sales complied with all specifications requested in the RFP. Staff recommends entering into a contract with Petrie Ford sales for the purchase of one 2019 model year, three-quarter-ton, high roof cargo van for the total purchase price and related costs of \$37,041 plus applicable taxes.

There is no electric vehicle equivalent available for this unit.
