The Administrative Policies Committee Reports and recommends as follows:

1. Tax Write Offs Pursuant to the Municipal Act, 2001

That Council approve the cancellation, reduction or refund of taxes pursuant to applications made under Sections 357 and 358 of the *Municipal Act, 2001* totaling \$22,492.08 of which \$14,207.64 is the City's portion and the amount charged back to the school boards and Downtown Kingston! BIA is \$7,821.49 and \$462.95 respectively, as listed in Exhibit A to Report Number AP-19-021.
