The Report of the Chief Financial Officer and City Treasurer (Report Number 19-314) is attached to the Agenda as Schedule Pages 41-88 and was distributed with the Budget Packages, wherein the following is recommended:

That any variance between final assessment growth and the growth estimates included in the 2020 general municipal operating budget be transferred to/funded from the Working Fund Reserve, to offset unanticipated variances in assessment growth in future years as a stabilization measure; and
