

Hello again, Wayne. I wasn't intending to contact you again on this issue but I've just been advised of a rumour that you're planning to speak against the STR bylaw amendment on behalf of Tourism Kingston. In the event that's true, I would strenuously urge you to reconsider.

This bylaw process has been a long and very stressful process which has, in my view at least, been unnecessarily adversarial and has engendered a lot of animosity. The amendment by APC Councillors is a well-considered attempt to bridge that gap, as was actually urged by the two tourism industry delegations who spoke at the November APC meeting. By imposing a full licensing regime, it fully meets the previously Council's directive which launched this whole exercise. Simultaneously, by removing the private-sector surveillance aspect, it eliminates the most egregious aspect of the staff proposal which I don't believe even had a mandate from Council.

In my email to you of the other day, I mentioned but didn't attach the detailed costbenefit analysis which I had recently undertaken. I ask that you review it, as it clearly demonstrates that the proposed surveillance regime would significantly reduce the City's net MAT revenues. Lots of hosts, myself included, would switch to medium term (31+ day) rentals rather than submit to such crap.

Since we're both political animals, I would also advise that, by visibly aligning yourself with the tourism lobby, you would in effect be yellow-circling yourself for the next municipal election. This whole ordeal has succeeded in politicizing a very active and engaged group of Kingston residents. The last time that I worked with such an effecting and highly motivated grassroots citizens' group was when, as president, I aligned the federal riding association and its members with the Save Our Prison Farms movement. The Harper government learned to its regret the cost of having dismissed such a group. It lost them Kingston's seat in Parliament which they had been poised to win. The prison farm issue was what made the difference in Brian Abrams withdrawing and Ted Hsu's subsequent narrow victory over Alisha Gordon, and the Conservatives haven't been serious contenders in this riding in any subsequent election. In this case, I would estimate that the hosts themselves, their families and friends and the small business owners who rely on hosts' free and enthusiastic referrals to their guests would amount to a block of a thousand voters.

You should understand the degree to which this group of voters sees senior staff as choosing to represent well-heeled hotel interests to the detriment of hard-working residents. The limited paper trail in Council documents points to their role as trusted insiders, which is supported by the degree of unquestioning copy and paste from the Hotel Association of Canada's anti-Airbnb handbook for municipal legislators. That perception was recently reinforced when one of our core host-activists took the initiative

to phone other municipalities which have chosen to have Airbnb collect the MAT at no cost. He reached the CEO of the Kitchener-Waterloo equivalent to Tourism Kingston who had the overall responsibility for MAT collection. She enthused about how easy and effective it was for her. I suggested that he call her back to see if she would be willing to share that experience with our Councillors. Sadly, she demurred for the simple reason that doing so would expose her to retribution from powerful hotel interests.

With senior staff utterly unwilling to negotiate a fair solution, hosts have learned to appreciate Councillors who have proven willing to put their constituents first and actively represent those constituents' interests. While hosts didn't get everything they wanted in the APC compromise, there's a lot of joy and appreciation in the sense that this long struggle is coming to an end with an acceptable solution that's sensitive to their utter antipathy to staff's proposed private-sector surveillance regime. It makes no logical sense to impose such measures without at least trying a simpler and more Kingston-like approach. Should the original staff recommendation be adopted this evening, surveillance will become a big issue in the next election and there will be a lot of emotive energy directed towards replacing Councillors who chose to spurn compromise and bring the surveillance society into our community. That at least is my reading of the political tea leaves.
