Whereas in March 2019 Kingston City Council became the first municipality in Ontario to declare a climate emergency; and

Whereas in May 2019 Council's Strategic Plan committed the municipality (the corporation and the community) to becoming carbon neutral by 2040; and

Whereas municipalities account for 50% of global emissions thus necessitating further action by all sectors and other levels of government; and

Whereas the Ontario government recently purchased 3 gas plants, a move that could lead to the increase of provincial greenhouse gas pollution by more than 400% by 2040; and

Whereas a number of municipalities, as partners in government, have passed motions to ask Queen's Park to reverse this decision in keeping with the need to reduce, not increase, greenhouse gas emissions;

Therefore Be It Resolved That the City of Kingston write to the Minister of Municipal Affairs and Housing and the Minister of Environment, Conservation, Energy, and Parks to request that the Government of Ontario develop and implement a plan to phase-out all gas-fired electricity generation as soon as possible to ensure that Kingston and other municipalities are enabled to achieve climate action goals (or "GHG emission reduction targets"); and

That that the City of Kingston write the respective portfolio critics, all party leaders in the Legislature, and the Association of Municipalities of Ontario, requesting that the Government of Ontario develop and implement a plan to phase-out all gas-fired electricity generation, and direct the IESO to accelerate the use of renewable electricity supply and energy efficiency in all sectors, in order to reduce provincial greenhouse gas emissions as soon as possible and bolster our competitiveness in the global cleantech marketplace and overall emerging low-carbon economy.
