Subject: Traffic By-law – Minor Amendments

Council Strategic Plan Alignment:

Theme: 3. Improve walkability, roads and transportation

Goal: 3.1 Repair roads and enhance the usability of sidewalks, walkways and paths to increase connections across the city through supporting our active transportation master plan.

Executive Summary:

This report requests the approval of amendments to By-law Number 2003-209, "A By-law to Regulate Traffic", to update the list of roadways under seasonal load restrictions. This housekeeping by-law update is intended to align with planned signage installations and current conditions.

On roads for which reduced load restrictions apply, motor vehicles with a load that exceeds the limits set out in Section 122 of the *Highway Traffic Act* are prohibited from being operated in the spring of each year. These restrictions are in place to protect roadways during the spring thaw, when damage to the roadway is more likely to occur from heavy vehicle loads.

This report requests that the amending by-law be presented for all three readings to allow for the by-law updates to be in place for this year's seasonal load restriction time period.

Options/Discussion:

This report recommends amendments to be incorporated into By-law Number 2003-209 - "A By-law to Regulate Traffic" to update the list of roadways under seasonal load limits. These changes are consistent with Council's strategic priority to improve walkability, roads, and transportation.

Updates to the Seasonal Load Limits roadways list (Schedule F-2) are recommended to align with planned signage installations and current road conditions. During this reduced load period, motor vehicles with a load that exceeds the limits set out in Section 122 of the *Highway Traffic Act* are prohibited from being operated on the roadways listed within Schedule F-2.

The roadways described in Schedule F-2 are designated as highways to which reduced load restrictions apply during the period from the first day of March to the thirtieth day of April, inclusive, of each calendar year. Seasonal load limits are in place to protect these specific roadways during the spring thaw when road damage is more likely to occur from heavy vehicle loads.

Updates to the Seasonal Load Limits roadways list (Schedule F-2) are also recommended to remove development haul roads that are no longer required and align with recent signage installations and road conditions.

The proposed amendments to Schedule F-2 are included in Exhibit A – Proposed Changes to By-law Number 2003-209.
