Executive Summary:

Prior to amalgamation, Kingston Township enrolled various natural gas accounts into a group purchasing plan with the Association of Municipalities of Ontario, through the Local Authority Services (LAS) Natural Gas Procurement Agreement, which continues to supply natural gas for these accounts.

Staff are requesting Council authority to cancel the LAS Natural Gas Procurement Agreement from 1988 and any subsequent agreements, which hedges natural gas purchases for various accounts. Facilities Management & Construction Services staff have completed an energy analysis and the City of Kingston no longer benefits from the partnership with LAS due to evolving energy markets. Upon cancellation of this agreement staff will proceed with issuing a Request for Proposal (RFP) for bulk purchasing through an Energy Broker. This will significantly reduce our natural gas fuel costs.

Staff are requesting Council to issue a by-law to repeal By-law 89-19 of the former Township of Kingston and all subsequent by-laws extending the agreement.

That Council authorize the Mayor and City Clerk to enter into any agreements or other documents required to give effect to the cancellation of the natural gas procurement agreement between the former Township of Kingston and LAS or other predecessor entities dated November 1988 to the satisfaction of the Acting Director of Legal Services.

Options/Discussion:

Background

The Association of Municipalities of Ontario (AMO) created the Local Authority Services (LAS) Natural Gas Program to help municipalities achieve savings through the bulk purchase of natural gas. The former Kingston Township (Seller) entered into an agreement with GASAMO, Direct Energy Marketing Limited, ICG Utilities (Ontario) Limited and Gas Purchase Direct Limited (Buyer) in November 1988 to purchase a volume of natural gas by Buyer. Council authorized entering into the agreement by passing By-law 89-19. The agreement had a term of one year, however it was automatically renewed for a twelve-month period unless the Seller gave 185 days notice prior to the automatic renewal, the deadline for cancellation is April 25, 2021.

Further by-laws were passed between 1990 and 1995 to amend this agreement. By-law 95-96 amended the Buyer so that the agreement could continue between Kingston Township and ECNG Inc. This agreement is still in place, and applies to the following facilities:

- Kingston Fire & Rescue 905 Woodbine Road
- 2709 Creekford Road
- 2701 Creekford Road
- Centre 70 100 Days Road
- Kingston Fire & Rescue 127 Days Road
- Neighbourhood Sharing 670 Front Road
- Kingston Fire & Rescue 500 O'Connor Drive Strategy

Facilities Management & Construction Services staff have completed an energy analysis and the City of Kingston no longer benefits from the partnership with LAS. The Agreement is a hedge and was designed to allow the City (Kingston Township) to avoid any potential price volatility. This was useful at the time of the original agreement, however as the energy markets have evolved, staff does not recommend continuing with this program. Currently through the LAS program, the City has paid a premium of \$1,600 last year for the procurement of Natural Gas as compared to market price.

Upon cancellation of this agreement, staff will proceed with issuing a Request for Proposal (RFP) for bulk purchasing of natural gas through an Energy Broker. This will reduce our natural gas fuel costs and allow savings to be reinvested into strategies and efficiencies related to our Energy and Asset Management Plan to further reduce GHG emissions.

The advantage of utilizing the bulk purchasing method is the ability to lock in rates at any time. If the price is low, saving expectations could be exceeded. All market analysis would be completed by the Broker as part of the contract. However, there is a risk with the bulk purchasing method of a potential for less savings, if the market demand is strained due to global events. Based on past performance and the ability to lock in rates at anytime this risk would be mitigated properly.

Payment to the Energy Broker would not impact Corporate finances as they are paid through the rates they provide us. The cancellation of the LAS agreement and the new bulk purchasing method will not affect any processes being done by Financial Services and will not create any additional administrative work.
