Kingston city council motion to call out Hillier's COVID-19 actions

KINGSTON — City council is to consider joining a pair of neighbouring municipalities in calling for the premier to censure independent MPP Randy Hillier.

Hillier has been outspoken in his opposition to government measures to curb the spread of the COVID-19 virus.

"Council will not silently stand by when members in our community are placed in harm's way through Mr. Hillier's wilful propagation of misinformation," states the motion from Portsmouth District Coun. Bridget Doherty and Lakeside District Coun. Wayne Hill, which also asks Premier Doug Ford to have Hillier's "unethical and harmful behaviour" investigated by the province's integrity commissioner and to take further action or sanctions.

"We are under a lockdown," Doherty said Friday. "Residents of Ontario have been told to stay at home, and most people, including businesses, are adhering to the restrictions because we know that this will reduce the number of patients in our emergency rooms and the number of lives lost.

"Mr. Hillier is a member of provincial parliament. He is travelling from town to town, spreading misinformation."

"As local representatives, we have a duty to safeguard and protect citizens," said Hill, adding that Hillier has "utterly failed in the responsibility."

"He is trying to get his 15 minutes of fame by preying upon folks who are frustrated, anxious and ignorant of the issues," Hill said. "He is doing this by disavowing the science that is supported by public health officials, doctors and other scientists, and in sewing this mistrust, his impact may very well last well beyond this pandemic."

On Sunday, <u>Hillier was fined</u> under the Reopening of Ontario Act for attending an anti-lockdown demonstration at the Church of God parish in Aylmer. The event was part of a series of such protests Hillier attended on the weekend.

Derek Sloan, the independent MP for the riding of Hastings–Lennox and Addington was also fined for attending the Aylmer rally.

Hillier is the MPP for Lanark-Frontenac-Kingston and represents city residents who live north of Highway 401.

Last month, South Frontenac Township passed a motion that stated the municipal council does not support Hillier's actions and that "this is not the way in which the Township of South Frontenac wishes to have this riding represented."

Kingston city council is to consider the motion at its Tuesday night meeting.

Good Afternoon,

I hope you are all doing well, or as well as one can be during these difficult times.

I am writing to address the upcoming motion regarding Randy Hillier.

It is a fantastic first step, and I applaud all those who are planning to vote in its support. He is spreading harmful misinformation and encouraging behavior that could be downright deadly.

I would also encourage council to urge the Ontario government to amend the relevant acts surrounding elections in such a way that would allow for the removal of a public official (MPP, Mayor or city council member) should he or she behave in an unethical fashion. I would be more than happy to help draft such an amendment (it's nice to use my Law Clerk skills for good).

It would also be prudent for council to spend some time considering where Hillier's supporters are coming from, as there may be more than a few watching tomorrow's meeting, and you have a unique opportunity to help change minds. Not all of them think that they are going to get microchipped and not all of them are fundamentally bad people. Some, probably almost all of them, are people who are in situations very similar to the one I was in and are just frustrated at not being helped, or even heard.

Me, I'm a single mom, and pre-pandemic, I had two jobs. One, as a law clerk, is a full time job. In March of 2020, I was bringing home between \$1,600 and \$1,800 per month. My rent was nearly \$1,000. Between OSAP repayments, internet, cell phone, and medications, I had about \$200 left over. That's \$200 for groceries, entertainment (like subscriptions or cable), bus pass, and other incidentals - with a 12 year old boy. Obviously, I needed a second job to make ends meet, which I had. And ends were just barely meeting.

Then the pandemic hit, and I lost my second job.

All of a sudden, ends were no longer meeting but I didn't qualify for any kind of relief. No CERB, no EI, no rent relief, no nothing. No one cared that I had to choose between putting food on the table and paying rent.

Then, I got another second job. I have Lupus, and the service industry was definitely not doctor recommended, but hey, ends need to meet, right?!

Then, yet another lockdown happened, and I lost my second job. Yet again, no CERB, no EI, no rent relief, no nothing.

The only difference between me and Hillier supporters is that while I was eating "pasta a la butter," I knew that this was only temporary and that these sacrifices we were all making were for the greater good. I choose to follow all restrictions without protest, because I know that by doing so, I am literally saving the lives of people in my community.

Hillier supporters only see that they are eating pasta with butter and are a month behind on rent, while politicians (and, my apologies) like you are still earning your full paycheques and (with all due respect) likely have not once in the last 18 months had to wonder where your next meal was coming from, or stayed up all night worrying that Ford would end the "no eviction" order, and you'd be on the hook for rent you can't pay.

The reasoning of certain Hillier supporters is this: why should we follow the orders of people who have no practical idea what the actual impact of those orders are?

It's one thing to say "stay at home," it's quite another to realize the economic impact of that each time you struggle to answer "Mom, what's for dinner?!"

So before you speak in support of this bill at tomorrow's meeting (which I hope you will all support), please take a moment and put yourself in the shoes of those Hillier supporters who aren't fundamentally bad, and the shoes of people like me, who are trying to do good but are still suffering. There is no relief for us, no CERB we can count on. No politician has tabled any legislation or motion that will provide us with any help. And while people like me understand the need to sacrifice for the greater good (if me eating dry pasta means that another person didn't have to get ventilated, it's totally worth it), others have a hard time seeing beyond their own fork.

Please try to exercise compassion toward those who are scared and who may have been attracted to Hillier because he offered them something no one else did: relief.

Because tomorrow, you have a unique opportunity to change minds. Not all Hillier supporters are immune to logic or are fundamentally bad people. By discussing the reasons for certain restrictions, as well as the importance of following them, with a degree of compassion and empathy regarding the very real economic costs of following these rules, you may be able to help those supporters who aren't bad people understand *why* it is important to comply with current regulations.


