Executive Summary:

By-Law Number 98-9, A By-Law to Appoint Municipal Law Enforcement Officers of The Corporation of The 'New' City of Kingston, appoints various City staff as municipal law enforcement officers for the purpose of enforcing City by-laws. Given the natural labour force changes for these positions, this process results in the by-law becoming quickly out-of-date and requiring frequent amendments to be brought to Council.

In this report staff are recommending that the authority to appoint municipal law enforcement officers be delegated to the Director of Building & Enforcement. This would allow for timely updates that coincide with the hiring of officers and streamline administrative processes for both staff and Council with regards to writing and passing by-law amendments. Under this delegated authority the Director would be responsible for keeping a register of all staff appointed to enforce municipal by-laws and making that register available for public viewing.

This recommendation requires the repeal of By-Law Number 98-9 in its entirety and an amendment to By-Law Number 2016-189, A By-law to Consolidate the Delegation of Powers and Duties.

Options/Discussion:

By-Law Number 98-9, A By-Law to Appoint Municipal Law Enforcement Officers of The Corporation of The 'New' City of Kingston, provides City staff and staff from other municipal agencies with the authority to enforce the following by-laws:

- Municipal Law Enforcement staff with the authority to enforce any municipal by-law;
- Select KFL&A Public Health staff with the authority to enforce By-Law Number 2002-231, "A By-Law to Regulate Smoking in Public Places and Workplaces in the City of Kingston" and By-Law Number 2008-95, "A By-Law of the Corporation of the City of Kingston to Control the Idling of Vehicles & Boats"; and
- Select Utilities Kingston staff with the authority to enforce By-Law Number 2006-122, "A By-Law to Provide for the Regulation of Water Supply for the City of Kingston" and By-Law Number 2008-192, "A By-Law to Provide for the Regulation of Waste Water Services and Discharges to Municipal Sewers for the City of Kingston".

The authority for this process is provided by the *Police Services Act*, Section 15(1) which states:

"A municipal council may appoint persons to enforce the by-laws of the municipality."

Given the natural labour force changes for staff positions that are provided the authority to enforce City by-laws under By-Law Number 98-9, staff are recommending that Council delegate this authority to the Director of Building & Enforcement as these appointments are strictly administrative in nature. Such a delegation of powers and duties is authorized under the *Municipal Act, 2001*, Section 23.1 and similar delegations of authority have been completed in Vaughan, Hamilton, London, Oakville, and Guelph.

Delegating this authority will allow for timely updates that coincide with the hiring of officers and streamline administrative processes for both staff and Council with regards to writing and passing by-law amendments. Under this delegated authority the Director would be responsible for keeping a register of all staff appointed to enforce municipal by-laws and making that register available for public viewing.

This recommendation requires the repeal of By-Law Number 98-9 in its entirety (Exhibit A) and an amendment to By-Law Number 2016-189, A By-Law to Consolidate the Delegations of Powers and Duties (Exhibit B).
