Subject: Award of Contract – Resurfacing Gardiners Road

Goal: 3.1 Repair roads and enhance the usability of sidewalks, walkways and paths to increase connections across the city through supporting our active transportation master plan.

Executive Summary:

On Wednesday May 5, 2021, Engineering Services closed a tender as part of the City's continued efforts to rehabilitate roads through capital preventative maintenance. Two submissions were received for Tender ENG-2021-04 Resurfacing Gardiners from Princess Street to Fortune Crescent.

In accordance with Section 6.5, Clause iv of the Purchasing By-law, approval shall be sought by report to Council when fewer than three tenders have been received. The purpose of this report is to seek Council approval to award the contract for the Resurfacing of Gardiners Road to Coco Paving Inc.

Recommendation:

That Council authorize the Mayor and Clerk to enter into a contract, in a form satisfactory to the Director of Legal Services, with Coco Paving Inc. for Tender ENG-2021-04 Resurfacing Gardiners Road in the City of Kingston.

Options/Discussion:

Staff issued a tender to procure construction services for the Resurfacing of Gardiners Road on April 16, 2021. The City's work included in this tender was identified in Council Report Number 20-195, Road Condition and Maintenance Update.

On Wednesday May 5, 2021, two tender submissions were received for ENG-2021-04 Resurfacing Gardiners Road in the City of Kingston from Princess Street to Fortune Crescent.

- Coco Paving Inc \$1,178,000.00 plus HST
- R.W. Tomlinson \$1,520,152.00 plus HST

Coco Paving Inc. is a reputable contractor that has successfully completed contracts for the City in the past. The bid received from Coco Paving Inc. is within the amount budgeted for the completion of this work. All aspects of their bid as submitted was compliant with the requirements of the tendering process and the overall procurement met trade treaty obligations. As only two bids were received, Council approval is required to execute the contact.

In 2020, Coco Paving Inc. was the successful contractor on a similar resurfacing project on Gardiners Road from Bath Road to Princess Street.
