Goal: 5.1 Increase access to and continue to beautify the waterfront.

Executive Summary:

The purpose of this report is to update Appendix D of By-Law Number 2004-190, "A By-Law To Regulate The Use Of City Streets" and therein also provide authorization for removal of the public notice board in front of the Visitor Information Centre (VIC) at 205 Ontario Street.

Appendix D of By-Law Number 2004-190, "A By-Law To Regulate The Use Of City Streets" provides the locations of public notice boards in the City of Kingston. Staff conducted an inventory on April 30, 2021 and determined that there are only four notice boards currently in place, contrary to the list of seven as noted in Appendix D.

As such, the Appendix requires amending, and additionally, Tourism Kingston is requesting removal of the public notice board that is in front of the VIC. As the area in front of the VIC is also undergoing concrete resurfacing, this removal would be timely.

Options/Discussion:

As noted in the executive summary, staff have determined that although Appendix D of By-Law To Regulate The Use Of City Streets" lists seven public notice boards, only four of those are currently in place. Below is the list and status of those boards.

Princess and Wellington Streets (northwest corner)	Yes
Alfred and Union Streets	. No
Market Street at the Kingston Public Market	. No
Ontario Street outside the Tourist Information Office	Yes
Ontario Street outside the Confederation Basin Office	. No
Portsmouth Olympic Harbour (two boards)	Yes
Princess and Tower Streets	

Tourism Kingston is also requesting removal of the public notice board that is in front of the Visitor Information Centre (VIC) at 205 Ontario Street. The VIC is owned by the City of Kingston and operated by Tourism Kingston as a multi-purpose facility that supports year-round residence and guest services, typically seeing over 200,000 guests annually.

Although people posting on the public notice board are to remove their postings within 48 hours after the event being advertised, most often this does not occur. This leaves much of the information being outdated and irrelevant. The public notice board can also become somewhat of an eyesore in what is a very high tourist traffic and highly photographed spot.

Tourism Kingston staff have noted that the public notice board has been steadily getting less utilization. This is not surprising as the majority of the public now rely on technology for information – whether that be their smart phones or other devices. This was part of the rationale for the installation of the new digital information kiosks inside the VIC as part of the interior renovations in 2020 that also maximized space for guest services.

As the main resource for event, attraction, and accommodation information, it is vital for the VIC to provide current and accurate information to all guests, and the most productive means to do so is paperless. It is also beneficial to continue efforts to enhance the attractiveness of this location.

With the concrete pad surrounding the Visitor Information Centre undergoing a resurfacing this year, staff would like to arrange the removal of this public notice board in concert with that work.
