Sydenham District Association 113 Lower Union Street – Indigenous Supportive Housing Project 2021-05-31

The board of the Sydenham District Association (SDA) supports the proposal for 113 Lower Union Street to be a residence and Indigenous housing services centre operated by Tipi Moza.

The proposal acts upon recommendations from the 10-year Municipal Housing and Homelessness Plan and the Mayor's Task Force on Housing which we also support.

It is important that our community and its organizations come together to say 'yes' for increased support for expanded and improved options for housing for all people. The proposal in this report is something that the board of the SDA would like to see City Council approve.

While we and the general public do not yet have a full understanding of all of the particulars of this proposal, it appears from the report that much of it aligns with both local and national strategies to address a lack of housing for all.

In a broad sense, we understand the following-

- There is a housing affordability crisis in Kingston and simply increasing supply will not solve that issue. We need to counterbalance commodification of housing with the provision of homes for all people throughout Kingston with a variety of purposeful supports.
- Affordable housing, whether *more affordable* or rent geared to income or below the market rate, requires support from all levels of government, potentially with assistance from partnerships with the public and not-for-profit or private sectors.
- Anecdotally if not statistically we apparently know that those municipalities that own, operate and actively participate in provisioning affordable housing solutions generally fare better when evaluated for availability and affordability of housing.
- Vacancy rates, record high rents and many other market indicators simply do not tell the complete story for those unable to access housing and those somewhat invisible aspects such as tenant selection processes are barriers to many people.
- There are systemic barriers to housing, and they are experienced more acutely by some members of our community than by others. The barriers range not only from economic inaccessibility and built form accessibility, but also include quality of life and health barriers. Why do we see so little affordable, rent geared to income and below market rate housing in Kingston's low-rise neighbourhoods? It seems unlikely that any of the additional units approved in Sydenham District and the downtown are affordable. There's evidence to the contrary, it's an expensive monoculture.
- Our understanding is that the uptake for the Second Residential Unit Affordable Housing Grant Program is not strong. Though most development applications carry the theme: 'Increasing Housing Affordability', we need to be clear about what developments will place marginalized community members and those at

risk in viable homes. In looking at the housing continuum and considering private development initiatives, it seems obvious that Affordability will not be meaningfully or widely provisioned through the type of projects we are seeing. This appears in line with information found in the consultant's report of the Mayor's Task Force on Housing regarding the current economics. What will it take to realize 100+ affordable units per year? To be economically viable, it will take government funding or philanthropy or both.

• The financial considerations might have additional context if compared to the total community benefit value of recent large development proposals, if those entire community benefits were applied to delivering Affordable units. Alternately, we could consider the cost of 18 secondary residential units as Affordable housing that would qualify for the grant program. Regardless of how Council or the public chose to present the financial considerations and recommendation, the reality is it will take a financial commitment by governments to proposals such as this to deliver diverse supply and housing choice and affordability for all people.

The SDA looks forward to welcoming Tipi Moza and its residents to our neighbourhood and community. Thank you for your time and consideration of our perspective.
