Executive Summary:

Purpose

Statutory Officials By-Law

By-Law Number 98-8, being "A By-Law to Appoint Statutory Officials of The Corporation of the City of Kingston" was passed by Council on June 9, 1998. Delegated Authority By-Law

Changes in staffing necessitates regular housekeeping amendments to the Statutory Officials By-Law. Currently, these housekeeping amendments are undertaken on an ad hoc basis. To improve efficiency and streamline the process, the Clerks Department will undertake a twice-yearly review of the Statutory Officials By-Law, in consultation with all City Departments.

Staff are recommending that the City Clerk, or their designate, be delegated the authority to make the necessary amendments as a result of staffing changes and place the by-law on a Council agenda for approval. Prior to the by-law being placed on the agenda the Clerks Department would provide notice to Council through the weekly update, or other electronic means.
