# **Options/Discussion:**

The City's Facilities Maintenance & Construction Services Department (FMCS) is responsible for the renovations, construction and maintenance of City owned buildings and properties. All work is planned to meet the Facilities Accessibility Design Standards (FADS) wherever feasibly possible. Below is a list of key accessibility items addressed in recently completed, current and future construction projects, as well as issues addressed during regular building maintenance and topics covered through staff training.

# 2022/2023 Construction Projects Highlights:

# City Hall:

Upgrade fire system with enhanced audible signals

# Fleet Maintenance Garage:

- Opened in 2021
- Detectable warning surfaces
- Power door operators
- Colour contrast on doors and wall/floor transitions
- · Accessible washroom facilities with room for future adult change table
- Audible and visual alarms

#### Kingston East Community Centre:

- Opened in 2022
- Accessible appliances
- · Audible fire alarm system and exterior crossings
- · Tactile surfaces, including to identify walking track

# Sleeping Cabins:

- 4 of the 10 cabins made accessible with custom built ramps
- New accessible shower facilities

#### Richardson Beach House:

- Power door operators
- Universal washroom with adult change table
- Widened corridors
- Accessible change rooms and washrooms
- Contrasting finishes on floors, walls and doors

#### Transit Bus Shelters:

- Turning radius within shelter
- Vision strips on glass and edges
- Tactile warning surfaces
- Bariatric seating
- Enhanced lighting

#### Rick Hansen Foundation Gold Certification:

 The Rideau Heights and Kingston East Community Centres were audited by the Rick Hansen Foundation for accessibility. Both facilities received a Gold rating, which is the highest level awarded by the Rick Hansen Foundation.

## Other upcoming projects include:

- Market Street Accessible Ramp Repairs, City Hall
- Transit administration, mechanics and storage buildings expansion

# **Key Maintenance Practices:**

Protective scaffolding installed annually over the Market Street entrance to protect staff and visitors from falling snow and ice. This allowed the accessible entrance to remain open throughout the winter and has become part of the regular winter routine.

#### **FMCS** Training:

Staff continually enhance their accessibility knowledge through various training opportunities.
