Executive Summary:

This supplemental report provides City Council with an update on the sleeping cabins program (April 16th Report Number 24-052 'Sleeping Cabin Wind Down Plan') based on information that City staff received today, April 16, 2024. Our Livable Solutions (OLS) notified City staff that they were contacted late last week regarding a private property option for the relocation of the sleeping cabin program. Staff are now requesting direction from Council to receive, review and then update Council on any proposals submitted by OLS prior to July 1, 2024 to relocate the sleeping cabins program on a privately owned property. While opportunities are explored by OLS, it is expected that they will continue to work with City staff and housing partners to prepare a plan for the residents who currently participate in the Sleeping Cabin program to transition to alternate housing solutions.

Options/Discussion:

City staff were contacted today by OLS to inform staff that there is a property owner in South Frontenac, Frontenac County, that has expressed an interest in making its land available for the operations of the sleeping cabins program.

OLS is interested in pursuing this option and has had discussions with various potential donors who have expressed support of this intent. OLS has requested time to develop an operational plan related to this opportunity that would be submitted to and reviewed by staff, and then subsequently shared with Council for consideration. The operational plan would include, but not be limited to, consideration of property zoning, water, electrical and sanitary servicing, on site amenities, transportation, access to support services, etc. Staff are recommending that this plan be provided by July 1, 2024 at latest to ensure that there is sufficient time to consider the proposal before the complete wind down of the sleeping cabins program on City-owned properties.
