a) Amendments to By-law 2003-405, A By-law to Regulate Fences

Mr. Willing provided the Committee with an overview of the Report.

Councillor Osanic asked staff if consideration was given to require a property owner to advise their neighbours of their intention to construct a fence between six and eight feet in height. She noted that residents are currently required to follow a similar process as part of the backyard hen application. Mr. Willing explained that from an administrative process standpoint this proposal would be difficult to monitor as a permit is not required to build a fence.

Councillor Berg indicated that she supports higher fencing for security and safety reasons.

Councillor Paterson questioned if there was discussion regarding permitting a fence eight feet in height should it meet certain conditions. Mr. Willing replied that certain conditions must be met if there is a pool on the property.

Councillor Paterson questioned if other municipalities have experienced issues with fencing eight feet in height. Mr. Willing responded that there have not been issues in other municipalities regarding this matter.

THAT a by-law be presented to Council, as attached as Exhibit A to Report AP-14-005, to amend By-Law 2003-405 "A By-Law to Regulate Fences within the City of Kingston" to allow fences to be up to 8 feet high, provide additional support to fences that are up to 6 feet high and to provide an alternative to fencing for above ground pools.
