2020 Property Tax Information



Residential Tax Bill Changes 2019-2020

Fire services are area-rated, causing tax rates to vary from area to area. The estimated average tax bill total has been updated to reflect an area weighted average fire charge. Tax bill changes will vary from the average as a result of MPAC property assessments that are above or below the average.

Why was the tax bill deferred?

Recognizing the financial hardship caused by COVID-19, the City adopted several measures to provide property owners with some relief. They included:

- Postponing the final property tax bill from June to August.
- Permitting residents on preauthorized payments to defer two monthly payments, upon request. If you have not already applied for this deferral, you may do so before Aug. 17 by emailing Tax@CityofKingston.ca.
- Automatically waiving interest on 2020 interim property tax levies for April, May, June and July.

Additional Assistance for Small Businesses:

If you own a hotel, motel or small business property, you may be eligible to defer your 2020 final property tax bill payment. This program is for commercial properties with a total assessment equal to or less than \$2 million, as well as hotel and motel properties who have been financially impacted by the COVID-19 pandemic. Eligible applicants will have their 2020 final property tax bill due date extended to Nov. 30, 2020. The deadline for submitting the application is Aug. 17. Applications must be submitted by the property owner.

Assessment and tax appeal information

If your property has undergone changes, you may be eligible to apply for a tax adjustment. For information and applications, please go to CityofKingston.ca/Tax. Note that taxes must be paid even if you are appealing your assessment. The City has no authority to cancel interest beyond the amount of tax reduction achieved if your appeal is successful.
