Assessment and tax appeal information

Due to the COVID-19 pandemic, the Ontario government's planned reassessment for the 2021-2024 assessment cycle was delayed. As a result, property assessments for the 2022 and 2023 property tax years will continue to be based on fully phased-in Jan. 1, 2016 current values. This means that, unless there have been changes to a property, property assessments for the 2022 and 2023 property tax year will be the same as the 2020 and 2021 taxation years.

If your property has undergone changes, you may be eligible to apply for a tax adjustment. For information and applications please go to CityofKingston.ca/Tax. Please note that taxes must be paid even if you are appealing your assessment. The City has no authority to cancel interest beyond the amount of tax reduction achieved if your appeal is successful.

Payment Options

To minimize in-person contact and avoid line-ups at the City Hall Payment Centre, property owners are encouraged to use one of the alternative payment options listed on the back of the property tax bill.

You may also join the Pre-Authorized Payment Plan. This plan is a convenient, worry-free, and secure option to pay property taxes over 10 monthly installments. Recognizing the financial hardship caused by COVID-19, the City is permitting residents on the monthly pre-authorized installment plan to defer up to two monthly installments to November and December 2022, upon request.

Tax payment receipts

Receipts are available by mail when you enclose a self-addressed stamped envelope with your tax bill. You may also present your tax bill to have it stamped "paid".

Are you interested in receiving future tax bills by email?

ePost is being retired in December 2022; however, the City is currently developing a portal that will allow residents to receive their tax bills electronically and view their tax account information.

⁽²⁾ As per Council direction, the recently approved request from the University Hospitals Kingston Foundation as well as the amount levied for the City's share of Frontenac Paramedic and Fairmount Home for the Aged services, as managed by the County of Frontenac, will be billed as separate components on the property tax bills.
