Why was the tax bill deferred?

Recognizing the financial hardship caused by COVID-19, the City adopted measures in 2021 to provide property owners with some relief. They included:

- Postponing the interim property tax billing from February to March and the final property tax billing from June to July.
- Permitting residents on the pre-authorized payment plan to defer two monthly payments, upon request. If you have not already applied for this deferral, you may do so before July 16 by emailing <u>Tax@CityofKingston.ca</u>

Assessment and tax appeal information

The Government of Ontario has postponed its planned 2020 property assessment update. The Province has indicated that property assessments for the 2021 and 2022 taxation years will be based on the fully phased-in Jan. 1, 2016 current values (i.e., the same valuation date used for the 2020 taxation year).

County of Frontenac 2021 Budget Requisition

 As per Council direction, beginning in 2021, the amount levied for the City's share of Frontenac Paramedic and Fairmount Home for the Aged services, as managed by the County of Frontenac, will be billed as a separate component on the property tax bills. The levy is based on the 2021 budget requisition received directly from the County.

Tax payment receipts

Receipts are available by mail when you enclose a self-addressed stamped envelope with your tax bill. You may also present your tax bill to have it stamped "paid".

Payment Options: To minimize in-person contacts at the City Hall Payment Centre, property owners are encouraged to use the alternative payment options listed on the back of the property tax bill.
